## Attention Boaters!




Boat Owners Association of The United States (BoatUS) is advising boaters with vessels that have a U.S. Coast Guard Certificate of Documentation to be wary of any letter arriving by U.S. mail offering renewal.

BoatUS advises that while the Coast Guard does send official annual renewal notices by U.S. mail, other notices being received by BoatUS members are not from the Coast Guard but rather third-party companies whose name or return addresses may appear similar to that of the official U.S. Coast Guard National Vessel Documentation Center (NVDC).

While third-party companies may legitimately provide services to assist with vessel documentation renewals, the Coast Guard's own renewal process is simple for most vessels and the price, \$26 annually, is often much lower than what third-party services may charge.

To renew, go to the U.S. Coast Guard National Documentation Center website and click on "instructions and forms," then "Certificate of Documentation Application for Renewal." The Coast Guard NVDC also offers renewal options up to five years for recreational vessels.

BoatUS also advises boaters who may have received mail that they believe is misleading or deceptive to contact the U.S. Postal Inspection Service at 877-876-2455 or through its website <https://postalinspectors.uspis.gov>.



### WHAT ARE THE REQUIREMENTS FOR A VESSEL TO BE DOCUMENTED WITH THE US COAST GUARD?

- Vessel must measure at least 5 net tons (10,000 lbs)
- Owned by a U.S. citizen

## House Rules for Grand Lagoon Yacht Club

---







The Grand Lagoon Yacht Club (The GLYC) and all the facilities of The GLYC are primarily for the use, entertainment, and enjoyment of the members and their families and guests. The House Rules of The GLYC are designed to facilitate and promote this purpose. The House Rules and any additions thereto are established and may be revised by the Board of Governors subject to the direction and approval of the Board of Governors. Members should be aware that:

- These rules are enforceable by any Board Member, Manager or Flag Officer present.
- Delinquency in financial obligations will result in denial of club privileges and possible expulsion from The GLYC.
- Any complaints, requests, or suggestions must be directed to the Board of Governors in writing.
- Violations of any of the above rules will result in action by the Board of Governors concerning the member(s) will be allowed a hearing and the Board of Governors' action may be appealed. However, if the member(s) in. Question is on the Board, he/she will not be allowed to vote in the appeal.
- Rules will be posted at all times.

### **HOUSE RULES** *(revised 2/25/2024)*

1. Members are responsible for signing in their non-member guests. The GLYC member shall be responsible for the guest's. Conduct, and the guest shall leave when the member leaves The GLYC.
2. Non-members that are not the immediate family of a member and live within 50 mile radius of the Club will be allowed in the Club no more than ten (10) times per year. Members of other reciprocal yacht clubs, providing proof of membership, are not considered guests. Transients temporarily renting a slip are allowed access to the club during the rental period. Frequent guests will be encouraged to join the club. The Board will review abuse of this rule and take action.
3. Prior members who have resigned from The GLYC and were not in good standing cannot be a guest of another member.
4. A person whom a member is dating is considered a guest, but the date may use the facilities of The GLYC as often as the date is accompanied by the member, provided that the date abides by all the rules and regulations of The GLYC.
5. Be appropriately dressed in The GLYC. No bathing suits, tank tops, or bare feet in The GLYC. Be at least casually dressed in good taste during the dining room hours.
6. Observe current opening and closing hours.
7. Refrain from offensive language, conduct, or intoxication. If offensive, a member may be asked to leave the premises by The GLYC management or Flag Officer and is expected to do so at once.
8. Refrain from going behind the bar, entering the galley during operation, or otherwise interfering with bar/galley functions.
9. Purchase all alcoholic beverages to be consumed on premises from the bar.
10. Be accountable for the conduct of your children. Children are not allowed at the bar other than the service station and must leave the area immediately after purchase.
11. Refrain from littering on the premises.
12. Members are accountable for their pets and their conduct; they must be on a short leash and in designated areas - downstairs, parking lot, east-side of upper deck.
13. Do not take club property (eg. Glassware, china, silverware, etc) beyond the dock.
14. Refrain from smoking, including e-tobacco products, "vaping," or use of all other tobacco products inside the club house.
