## FROM THE COMMODORE:

Hey Everyone! Well, November slipped by way too fast, and now we're into the serious holiday season. In my previous Lagoon Lines article, I requested you all come out to the upcoming November All Hands meeting, and I was very happy to see a really good turnout. So, thanks for coming out, and thanks to all of you for asking your questions and expressing your opinions on the possible dues and price increases we were looking at. As I promised at that All Hands meeting, we did have a vigorous and spirited Board meeting the following week, and several very hard decisions were made.

I mentioned at the All Hands meeting that I thought the monthly dues increase would be in the area of \$25; that's what our preliminary estimate showed would be appropriate. After looking at the latest data and having a long philosophical discussion among the Board members, we decided to actually increase the monthly dues to **\$130**. This increase should put us into a positive economic

status for the foreseeable future, and will also provide some additional cushion to allow us to build up our reserves to where they should be. Remember, I said before that my personal belief was that all areas of the Club should bear the load so that no one particular area or group would be unfairly burdened. That turned out to be a general consensus among the Board. Since the dues went up 30%, we decided to increase the other areas by an equal percentage. What does that mean? Here's a breakdown:

**Monthly Dues:** Increase from \$107 to \$130 per month.

**Marina Costs:** Increase both East and West slip fees by \$3 per foot.

**Dry Storage:** Increase monthly fees from \$55 to \$70 per parking spot.

**Boat Storage on Beach:** Increase from \$10 to \$25 per boat, no exemptions.

**Beverages:** Increased across the Board on a sliding scale.

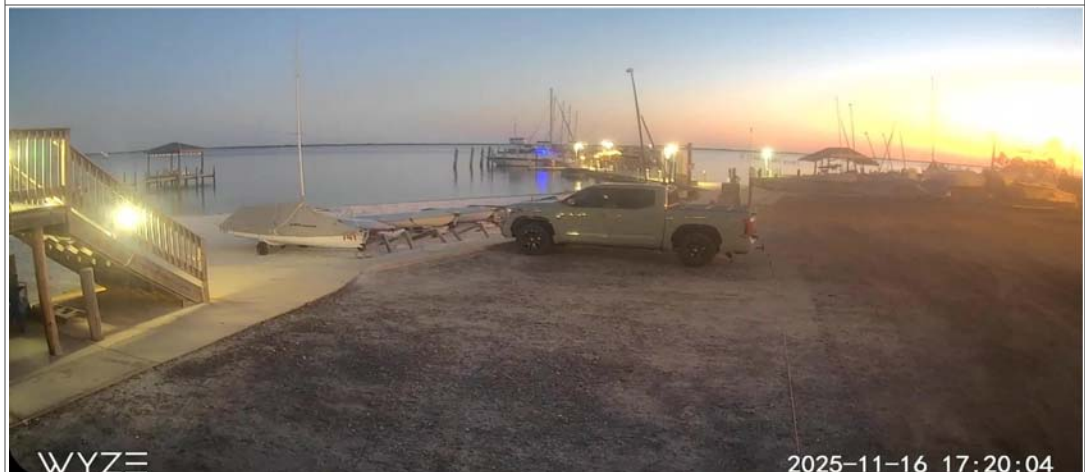
**Food:** Prices will increase as needed with market conditions. A new menu with adjusted food prices will be coming out before the new year.

The Board and I know that some of these changes will not be popular, but I assure you we did not take any of these actions lightly. But, the Board was primarily focused on ensuring the continued viability and solvency of our Club. We think these steps will do that. We also firmly believe that GLYC is still the **BEST DEAL IN TOWN!** For food and entertainment, social activities, sailing and boating activities, and the camaraderie of our Members.

One more reminder, please join us at the Club on **December 10th**, from **5 to 7 PM**, for Election Night. We've seen in the past that one or two votes can make a big difference in who gets elected. We have a very fine slate of candidates, and I really hope we turn out in good numbers to get the Board we need to carry us into the future. Thanks.

### IT'S GLYC ELECTION SEASON !!



The offices up for the annual election are **all the Flag Officers and two Board Members**. The responsibilities of these offices are outlined in detail on pages 2 and 3 of the bylaws, but the following are brief excerpts of the descriptions.

**Election: December 10, 2025**

**Commodore:** presides at all official meetings and performs functions as directed by the Board of Governors.

**Vice-Commodore:** second in command and supervises food and beverage services and all other functions related to the clubhouse operations.

**Rear Commodore:** third in command and monitors all external operations of the Club, including buildings, grounds, piers, docks, etc.

**Fleet Captain:** supervise the Club Sailing Committee and maintain club-owned boats, oversee races, regattas, etc.

**Secretary:** keep records of all official Club meetings, maintain the bulletin boards, produce the monthly newsletter, and other duties as described in Article II, sec 1, para 5 of the bylaws.

**Treasurer:** monitor all Club income and financial obligations, furnish a monthly financial report to the Board of Governors, and perform other duties related to the office.

**Board Member:** This office is for a two-year term. Board Members will attend all the monthly Board of Governors meetings and perform such actions as deemed appropriate by the Board.





## Vice Commodore

My name is Jeannette Prince, and I am running for Vice Commodore at the GLYC. We have been members since 2022 and have thoroughly enjoyed our time spent with everyone. I have been in charge of the Hargreaves Fishing Rodeo in 2025 and 2026 and have worked on various committees within the rodeo. I helped with the Thanksgiving dinner, Biloxi trips, murder mystery dinner, help when the club has been short-staffed, and 5050 raffles on Friday night. I want to be Vice Commodore because I think with all my experience, I can help the club become better than how I received it and make lasting memories for all members. I helped to start a special event facility in Atlanta that opened in January of 1992. We did all kinds of events from Proms to bar mitzvahs to corporate meetings with guests from 100 to 3500. The largest event that I ever worked on was in June of 2017, when I helped with the Rotary International conference in Atlanta for 35,000 people. I helped to coordinate travel, entertainment, food, and beverages volunteers of 4,000 people. In 2006, I started in the medical industry as CFO and HR Director and was responsible for meetings and trade shows, hiring and firing employees in 17 different states, and all accounting matters. In 2019, I left the medical industry to work at Southwind Marina in Pensacola, FL. I was able to make the marina cash flow positive by June of 2020, before hurricane Sally hit and destroyed the marina. It was the first time in 30 years that the marina itself became cash flow positive. After rebuilding the marina from scratch, I was able to make the marina cash flow positive once again in 2023.

## House Rules for Grand Lagoon Yacht Club

---

The Grand Lagoon Yacht Club (The GLYC) and all the facilities of The GLYC are primarily for the use, entertainment, and enjoyment of the members and their families and guests. The House Rules of The GLYC are designed to facilitate and promote this purpose. The House Rules and any additions hereto are established and may be revised by the Board of Governors subject to the direction and approval of the Board of Governors. Members should be aware that:

- These rules are enforceable by any Board Member, Manager or Flag Officer present.
- Delinquency in financial obligations will result in denial of club privileges and possible expulsion from The GLYC.
- Any complaints, requests, or suggestions must be directed to the Board of Governors in writing.
- Violations of any of the rules will result in action by the Board of Governors concerning the member(s) will be allowed a hearing and the Board of Governors' action may be appealed. However, if the member(s) in question is on the Board, he/she will not be allowed to vote in the appeal.
- Rules will be posted at all times.

### **HOUSE RULES** (revised 2/25/2024)

1. Members are responsible for signing in their non-member guests. The GLYC member shall be responsible for the guest's conduct, and the guest shall leave when the member leaves The GLYC.
2. Non-members that are not the immediate family of a member and live within 50 mile radius of the Club will be allowed in the Club no more than ten (10) times per year. Members of other reciprocal yacht clubs, providing proof of membership, are not considered guests. Transients temporarily renting a slip are allowed access to the club during the rental period. Frequent guests will be encouraged to join the club. When a violation is brought to the attention of the Board, the guest book will be reviewed by two Board members and action will be taken.
3. Prior members who have resigned from The GLYC and were not in good standing cannot be a guest of another member.
4. A person whom a member is dating is considered a guest, but the date may use the facilities of The GLYC as often as the date is accompanied by the member, provided that the date abides by all the rules and regulations of The GLYC.
5. Be appropriately dressed while in the Club. No bathing suits, tank tops, or bare feet in the Club. Be at least casually dressed in good taste during the dining room hours.
6. Observe current opening and closing hours.
7. Refrain from offensive language, conduct, or intoxication. If offensive, a member may be asked to leave the premises by The GLYC management or Flag Officer and is expected to do so at once.
8. Refrain from going behind the bar, entering the galley during operation, or otherwise interfering with bar/galley functions.
9. Purchase all alcoholic beverages to be consumed on premises from the bar.
10. Be accountable for the conduct of your children. Children are not allowed at the bar other than the service station and must leave the area immediately after purchase.
11. Refrain from littering on the premises.
12. Members are accountable for their pets and their conduct; they must be on a short leash and in designated areas: downstairs, parking lot, east-side of upper deck.
13. Do not take club property (eg. Glassware, china, silverware, etc.) beyond the dock.
14. Refrain from smoking, including e-tobacco products, "vaping," or use of all other tobacco products inside the club house.
